# FIRE, POLICE & CIVIL DEFENSE COMMITTEE MEETING JULY 14, 2021

This meeting was called to order at 7pm by Chairman Gary More.

Attendance: Peter Doman, Donald Luedtke, Gary More, Rick Pribnow, Jennifer Priesgen, Scott Ritger

Absent: Eric Kohlmann

Public Attendance: Keith Joas, Nick Roskopf, Jenna Rhein, an anonymous caller, Mitchell Keller of the Dodge County Pionier

The proposed public safety referendum was discussed. Gary and Scott reported that they met with Bryan Frank to rediscuss the cost of an officer. Initially, it was suggested the referendum would be for \$250,000, which would cover two full-time police officers – maintain the fourth full time and hire a full-time school resource officer (SRO).

Gary reported the figure can be changed to \$99,000 for a full-time officer and \$12,000 to equip the officer/savings/wage increases for a cost of \$\$111,000.

The committee agreed the referendum should propose two separate questions: one for police and one for fire department. The police referendum will be for \$111,000 and the fire referendum will be for \$64,000, which will cover the annual payment installment on a ten-year note for a new fire truck. Both referendums will be for an indefinite amount of time (no term limit).

The approximate impact on such a referendum will be \$65.60/\$100,000 valuation for the police referendum and \$41.99/\$100,000 valuation for the fire truck referendum.

The committee will meet with Bryan to discuss hiring a part-time school resource officer to replace the current part-time school resource officer upon retirement.

Jenna Rhein presented numbers on the general fund budget to show that financial changes need to be made in order for the Village to continue its operations. If all departments stay within the same budget as 2021 (with no changes), then \$17,800 has to be cut initially to balance the 2022 budget. The 2021 budget was balanced by "borrowing" money from the pool not opening in 2020 due to covid.
