FIRE, POLICE & CIVIL DEFENSE COMMITTEE MEETING MINUTES APRIL 28, 2021

This meeting was called to order by Chairman Gary More at 6:30pm.

Attendance: Peter Doman, Gary More, Scott Ritger

Public Attendance: Eric Kohlmann, Donald Luedtke, Jenny Priesgen, Bryan Frank, Keith Joas, Jenna Rhein

The committee met to discuss fire department future equipment needs and if this could tie into the referendum for spring 2022.

Keith Joas reported the second pumper will be out of NFPA compliance and can be replaced for approximately \$530,000. Keith also reported the costly repairs the other vehicles need. For example: tender #1 will need 10 new tires which cost \$450 each; tender #2 will need 6 new tires, brakes, exhaust, and suspension repairs; the rescue truck needs brakes and a complete exhaust replacement.

Keith also reported the fire department needs updated computers at the station and a printer.

The committee addressed possibly adding a cost for these equipment needs to the referendum. The committee agreed it will be a public safety referendum and will need to determine what amount added to the tax levy will be favorable by the public. Scott Ritger stated he was in favor of hiring a fourth full time officer now because it was shown the Village could afford the officer until 2022, but if the referendum doesn't pass then a police officer or public works laborer position may be cut.

Jenna Rhein will put an estimate together on how the tax bill will be affected by adding \$250,000, \$350,000, \$500,000, \$750,000 to the tax levy.

The committee will meet again on May 12 at 6:30pm.

Motion by Tr. Ritger, seconded by Tr. Kohlmann to dispense reading of the previous meeting minutes and approve as emailed. Motion carried.

Pr. Luedtke read a proclamation of appreciation to Girl Scout Troop 8113 for their community service.

Motion by Pr. Luedtke, seconded by Tr. Ritger to approve the 2021-2022 committee assignments as discussed. Motion carried.

Motion by Tr. Ritger, seconded by Tr. Priesgen to adopt Resolution # 997, appointing official Village depository as TSB Bank. Motion carried by roll call vote.

Motion by Tr. Ritger, seconded by Tr. Pribnow to adopt Resolution # 998, appointing official Village attorney as Richard Yde of Stafford Rosenbaum LLP. Motion carried by roll call vote.

Motion by Tr. More, seconded by Tr. Priesgen to adopt Resolution # 999, appointing official Village newspaper as the Dodge County Pionier. Motion carried by roll call vote.

Motion by Pr. Luedtke, seconded by Tr. Ritger to authorize Chief Frank to purchase a 2021 Ford F150 Police Responder truck not to exceed \$35,000 from equipment savings. Motion carried. Chief Frank reported the 2021 truck is a good deal and can be purchased at the 2019 price and costs less than an SUV. Since there are four police officers, they will now have four squads. The 2013 squad will eventually need to be replaced. The truck is expected to be delivered in November. Chief Frank reported he will outfit the vehicle from the remaining 2021 end of year budget and add to outfit it in the 2022 budget.

Motion by Tr. Kohlmann, seconded by Tr. Pribnow to allocate 2020 unexpended public works budget in the amount of \$7,860.16 to public works equipment savings. After further discussion about current budget status, motion by Tr. Priesgen, seconded by Tr. Ritger to table consideration. Motion carried with Pr. Luedtke and Tr. Pribnow nay. Tr. Doman reported the department came in under budget from wages and benefits and should be left in the general fund balance. Pr. Luedtke stated the wages and benefits were under budget due to staff turnover. He also stated that equipment repair costs are increasing, and the money should be put into savings for unbudgeted costs. Tr. More recommended a policy be put in place to address how over/underages are handled in the future.

Motion by Tr. Doman, seconded by Tr. Kohlmann to table consideration the sale of parcel 146-1317-1544-011 owned by the Village of Lomira, located at the southwest corner of South Avenue and Pleasant Hill Avenue. Motion carried with Tr. Ritger, Pr. Luedtke and Tr. Priesgen nay. John Krentz owns the property south of this lot and is interested in purchasing the lot for approximately \$1,000-\$1,500 and pay for closing fees, deed transfer, etc. Tr. Doman would like

to see a published notice of the intent to sell the property and notify the adjoining property owners. Jenna Rhein will publish a notice, mail the adjoining property owners and the topic will be revisited in June.
