FIRE, POLICE & CIVIL DEFENSE COMMITTEE MEETING FEBRUARY 12, 2020

This meeting was called to order at 6:30pm by Kraig Kietzer. Gary More was present, Donald Luedtke arrived at 6:45pm.

Scott Ritger, Ken Sarah, Keith Joas, Dale Krueger, Brian Ries, Bryan Frank, Eric Kohlmann and Jenna Rhein were also present.

Brian Ries presented information from the recent Theresa Ambulance committee meeting. The Town of Theresa and Village of Theresa are interested in having the Village of Lomira as an equal partner in ambulance services. Currently, the Village of Lomira has an annual contract with Theresa Ambulance and a flat fee is paid based upon population. The fee is approximately \$9.50/person. If the Village were to become partner with the Town and Village of Theresa for ambulance, it would cost approximately \$4,000 plus additional fees for equipment, maintenance, staffing.

Brian Ries reported 60% of the calls are to the Village of Lomira. The ambulance service costs approximately \$211,000 to operate, with a \$75,000 loss due to medicare.

The committee agreed it would not be economically feasible for the Village to join in partnership.

The committee also suggested the Village should gather quotes from Campbellsport and Mayville for ambulance service.

The meeting adjourned at 7pm.
